3. Purpose of the meeting

Matters to be reported

1. The Business Report and Consolidated Financial Statements, as well as the results of audits of the Consolidated Financial Statements by the Financial Auditor and the Audit & Supervisory Board, for the 75th fiscal year (from April 1, 2025 to March 31, 2026)
2. The Non-consolidated Financial Statements for the 75th fiscal year (from April 1, 2025 to March 31, 2026)

Matters to be resolved

Proposal No. 1: Appropriation of Surplus

Proposal No. 2: Election of Five Directors

4. Matter determined upon convocation (guidance on the exercise of voting rights)

- (1) If there is no indication of approval or disapproval of each proposal on the document you returned (by postal mail), it will be treated as an approval vote for such proposal.
- (2) If you exercise your voting rights in duplicate both in writing (by postal mail) and via the Internet, only the exercise of voting rights via the Internet shall be deemed effective.
- (3) If you exercise your voting rights via the Internet multiple times, only the last vote shall be deemed effective.

- ◎ If you attend the meeting on the day, please submit the voting form to the reception desk at the meeting venue.
- ◎ If revisions to the matters subject to measures for electronic provision arise, a notice of the revisions and the details of the matters before and after the revisions will be posted on the Company's website and the TSE website.
- ◎ For this general meeting of shareholders, paper-based documents stating the matters subject to measures for electronic provision will be delivered to all shareholders, regardless of whether or not they have requested them. However, in accordance with the provisions of laws and regulations and Article 15 of the Company's Articles of Incorporation, the following matters are not included in the documents to be delivered.
 - 1) "Systems for Ensuring the Properness of Business Activities" and "Overview of Operation Status of Systems for Ensuring the Properness of Business Activities" in the Business Report
 - 2) "Consolidated Statement of Changes in Equity" and "Notes to Consolidated Financial Statements" in the Consolidated Financial Statements
 - 3) "Non-consolidated Statement of Changes in Equity" and "Notes to Non-consolidated Financial Statements" in the Non-consolidated Financial Statements
 - 4) "Accounting audit report on the Consolidated Financial Statements," "Accounting audit report on the Non-consolidated Financial Statements," and "Audit report by Audit & Supervisory Board" in the Audit Report

In addition, the Audit & Supervisory Board Members and the Financial Auditor audited documents subject to audit including those described above.
